Call to Order: Mayor Mark Petterson called the meeting to order at 7:00 p.m.

Flag Salute: The meeting opened with the Pledge of Allegiance.

2020 Budget Hearing:

Haehn moved, seconded by Croll, to enter into a Budget Hearing for the 2020 proposed budget. **Motion carried 5-0.**

Mayor Petterson explained the public hearing was open. The proposed budget for 2020, if approved, will raise \$153,543 from property taxes at a tax rate of 40.546 mills which is a slight decrease of approximately .3 mills from last year. (SEE ATTACHED 16 PAGES/BUDGET)

City Superintendent Report

Zoning Administrator Report

There was discussion regarding permit fees for roofing. City Attorney Tom Robrahn will research and a decision as to whether to charge per the fee schedule approved in May will be determined.

There was discussion regarding a request for an in-ground swimming pool for Jacquie Mitchell. The city clerk noted that she had spoken to Jacquie on two occasions as well as several times with the contractor from Town and Country Pools. The City just received the drawing the
