Update on former golf course

In May, the New Strawn governing body explored the possibility of purchasing the former Prairie Winds Golf Course, a 77-acre public golf course that closed at the end of 2018. The effort would have required participation from the Coffey County Board of Commissioners and the USD 244 Recreation Commission.

In a matter of weeks, a golf "expert" was contacted as was an administrator of a city with a municipally-owned golf course. Financial information from several municipal golf courses was obtained and a group of volunteers formed. Several special meetings were held regarding the golf course attended by the public. The issue moved forward faster than most city issues, in an attempt to "save" the greens for play in 2019, in the event the city successfully purchased the course.

The Coffey County Board of Commissioners offered to loan the city \$250,000 at zero percent interest over a term of 20 years with the first payment delayed until 2023. Contracts were drafted for review at the June 13 city council meeting. The Rec Commission met June 14 for their regular meeting, the day after the New Strawn City Council meeting.

At the June 13 city council meeting, the city council decided it did not need to know the Rec Commission's monetary commitment for the golf course and unanimously voted

NOT to purchase the land, building and equipment.

At the July 11 city council meeting, which was attended by a number of citizens, the council reaffirmed the city would not operate a golf course; however, they would reconsider the possibility of getting the land for future recreational opportunities.

At the July 15 county commission meeting, commissioners were willing to provide a loan, if the city decides to purchase the land. The Rec Commission indicated the possibility of developing some recreational uses in the future. While the Rec Commission can develop and maintain land, it cannot purchase land.

A number of grants are available for recreation, parks, etc.; however, there is an application process and grants are not awarded overnight.

Possible uses for the land include: disc golf, walking/nature trails, foot golf, soccer fields, bike trails, fishing, and much more.

The city council is exploring the purchase of the land. The council planned to meet for a special meeting Friday, July 19, to determine whether or not to negotiate for the land. If the council decides to negotiate, a final decision will not be made until a future meeting. The public will be notified about any meeting related to purchasing the former golf course: fliers on the door, webpage, newspaper notice and email to those who are signed up for email notifications.

NEWSTRAWN.ORG is the City Hall website where you can go online to pay your bill, read minutes, read city ordinances or check out upcoming community events. You can also find forms such as new account applications, community building reservation and other li-

censing forms.

If paying your bill online, there is a 2.5 percent fee for credit cards and \$1.50 if paying with your checking account. To avoid these fees charged by KanPay (not the City of New Strawn), you can pay in person or use the night drop box.

ANIMAL REGISTRATION AND TAGS: REMINDER Any dog or cat over six months of age shall be annually registered with the city clerk. Fees of \$2 for each neutered male and spayed female and \$5 for each unneutered male and unspayed female are due in January. Fees will double in price for each month's delinquency, i.e.: February, \$4 and \$10; March and beyond up to a maximum of \$8 and \$20. Tagging your pet is also for your "peace of mind." Even dogs and cats that live almost entirely in the house occasionally escape outdoors and a tag makes it much easier to reunite an owner with an animal. Any owner or harborer of an animal that is found to be without a current license may be fined.

CITYWIDE GARAGE SALE: New Strawn and Burlington Citywide Garage Sales will be held August 3. There will be a separate map for New Strawn available at Casey's, New Strawn Branch of the Coffey County Library, and City Hall; however, Burlington Rec Center is where you will need to pay \$5 by July 29 at noon to be listed.

COMMUNITY CENTER: The rental fees for the Community Center for 2019 are as follows: Half Day or less \$50, Full Day \$100, and For-Profit Venue/Event \$150 per day.
