### Thank you, New Strawn

It's official. I am starting to feel like an "old-timer."

Actually, it's official, I am no longer a resident of New Strawn. I married Becky Richwine and moved to Burlington right around Christmastime. Rhonda Taylor, who served as city council president, was sworn in as mayor on Dec. 30. I definitely surprised her with the news, but I know she will do what is in the best interest of the residents of New Strawn.

I know what it feels like to be "surprised." I moved back to New Strawn, the town I grew up in, during Christmas of 2000, several months after my father's death. By the spring, it was election time and several residents conspired to writein my name for an open city council seat. I was definitely surprised. I had no aspirations to hold an elected office (other than precinct committeeman), but I decided to give it a try. Next thing I knew, I was running for mayor two years later and won. That was 18½ years ago.

It's hard to believe how time flies ... then you are an old-timer.

My parents moved to New Strawn from Topeka in 1972 BWC (Before Wolf Creek). No family in the area. No other ties. My father was retired from the U.S. Air Force and they just wanted to get out of Topeka. Apparently they liked the area and the schools (score!). I started in second grade, my sister, Sonia, in kindergarten and my brother, B.J., was four.

About everyone knows New Strawn got its start around 1964 when the original town of Strawn was flooded due to the construction of John Redmond Reservoir. The new town was officially incorporated in 1970.

Back in 1972, Arrowhead Hills was a brand new subdivision and our house was the fifth house built. I believe the town's population just topped 100 (it's about 400 now). Several years later, I had a paper route and I had as custom-

ers the real old-timers -- Boyce, Williamson, Claycamp, Ferris, Wheeler, Jackson, Mitchell, Fisher, Skillman, Tompkins, Rathke, Bahr, Hayen, Ellis, Chester, Payne, Garrett and Rich, to name a few. Most are gone, but a few remain.

Remembering what things were like 50 years ago and how so many things have changed over the years really makes me feel like an old-timer. Back then, the water was pumped from wells and at times was rust-colored. Anyone who remembers that can appreciate the water improvements (tower and distribution lines) completed 20 years ago, just before I moved back. The last water loan payment will be made in July and New Strawn will officially be DEBT-FREE for the first time ... probably in its existence. That will be something to celebrate!

Other infrastructure improvements have been made, including sewer and streets. The city lake underwent a major transformation in the 1980s and playground improvements have been made. More park improvements will be made in the future as well as improvements to the community building and much more.

During my time as mayor, I really enjoyed the people – our city employees, citizens and council members. Our city employees really make things run smoothly. Their knowledge and longevity make a huge difference in being able to do things that benefit the citizens of New Strawn. Having a diverse city council working to benefit the citizens also is a must.

While I may feel like an old-timer now, I didn't feel that way over 20 years ago. I hope some of New Strawn's younger citizens, will consider becoming involved in city government, or volunteer for community events. You won't regret it.

Of course, New Strawn will always be "home" to me. Thank you everyone for your support over the years.

#### Snow and ice removal on city streets

Please DO NOT park vehicles in the street during inclement weather, especially along the emergency routes: Neosho Street to North 4th Street (ALL of 4th Street is an emergency route), Cherokee Street to Main Street and ALL of Main Street, including Arrowhead Drive. Vehicles parked in the street make it difficult to effectively treat the streets for icy con-

ditions as well as impede snow removal.

Snow removal will be limited if accumulation is less than 2 inches, designated emergency routes and school bus routes will be addressed with either snow removal or salt and/or sand treatment, possibly both. Other residential streets will be addressed after the emergency routes and school bus routes are finished.

## Animal registration and tags

REMINDER: Any dog or cat over six months of age shall be annually registered with the city clerk.

Fees of \$2 for each neutered male and spayed female and \$5 for each unneutered male and unspayed female are due in January. Fees will double in price for each month's delinquency, i.e.: February, \$4 and \$10; March and beyond up to a maximum of \$8 and \$20.

Tagging your pet is also for your "peace of mind." Even dogs and cats that live almost entirely in the house occasionally escape outdoors and a tag makes it much easier to reunite an owner with an animal. Any owner or harborer of an animal that is found to be without a current license may be fined.
