STAFF REPORTS

Zoning Administrator no report

Code Enforcement Officer/Public Safety

Code Enforcement Officer Randy Rogers reported having signed several having permits. He also mentioned an area that the lane was being used as a parking lot. He requested that street signs be used to show public right of way and shoulder so the public roadway remains clear. Maintenance Operator Dwight said road signs have been ordered for the area and will be installed in the NW corner. City Attorney Wright said citations can be issued. Rogers is moving forward on other nuisance properties.

Maintenance Operator

CF CO RWD3 - 17th & Kafir - Maintenance Operator Dwight reported that Rural Water #3 may be interested in tying into the city water line near 17th & Kafir for a possible new owner in the area. Charges would be the cost of the water meter, a \$1,500 connect fee, \$36.50 water maintenance fee and \$13.77 per thousand.

Christiansen moved grant the request made by RW3 to connect with the out-of-town rates. Motion failed. Haas moved, seconded by Christiansen to allow RW# to place a meter at 17th and Kafir for \$1,500 and charge out of town rates. **Motion carried 4-0.**

Water Meters

Christiansen moved, seconded by Haas, to sell ipearl water meters purchased in 2020 at cost. **Motion** carried **4-0**.

Mower

Haas moved, seconded by Christiansen, to purchase from Coffey County Honda the Hustler Turf mower for \$15,900.00. Motion carried 4-0.

Something failed in the telemetry system for the water tower but the company will be here early next week to look at it. The water tower will need to be manually filled until it is fixed.
