## Register your pets in January

Animal licenses for 2019 need to be purchased at New Strawn City Hall by Jan. 31. Bring proof of rabies vaccination; you do NOT need to wait until it is time to have your pets vaccinated to register them. Simply bring in proof of the most recent rabies vaccination that shows your pet is up-to-date. Some customers may be under the impression they have to wait until after the vaccination date to come in; however, that just results in an increased fee for the registration. You can drop off an updated vaccine record at City Hall later in the year. Cost of registering your pet is: \$2.00 for animals that are spayed or neutered; \$5.00 for unaltered animals. Licenses are valid for the 2019 calendar year. If

you forget to do it in January, don't panic. You can still get your pet registered in February or March, but the cost of the license doubles for each month you are late...\$4 and \$10 in February, \$8 and \$20 in March.

### REMINDER

Any owner or harbinger of an animal that is found to be without a current license may be fined up to \$500, plus any cost incurred by the city related to enforcing the animal code. Tagging your pet is really more for your 'peace of mind' than anything. Even dogs and cats that live almost entirely in the house occasionally 'escape' to the great outdoors and a tag makes it much easier to reunite an owner with an animal.

## Trout stocked in city lake

This year, 682 trout were stocked on Jan. 14 averaging more than three quarters of a pound each. New Strawn's trout come from Southwest Missouri.

In addition to a current Kansas fishing license, a city fishing permit is required. The daily creel limit is two. There is a 'No Catch and Release' provision in effect as once they have been hooked, they will die.

City fishing permits are sold with a trout stamp through May 1 at City Hall as well as at Casey's, and Coffey County Honda. We truly appreciate these businesses helping us sell the

permits!

Cost is as follows: Residents of USD 244 Burlington and New Strawn area – Adult \$10, Youth \$4. Residents living outside of USD 244 – Adult \$15, Youth \$6. Anyone at least 16 years old must also possess a Kansas state fishing license.

The Rec Commission contributes \$1,500 annually to New Strawn for the purchase of the trout, and we truly appreciate their generosity!

Please, do NOT attempt to venture out onto the icy lake to fish. Shoreline fishing is permissible, but ice fishing is not.

## Snow and ice removal on city streets

Please, DO NOT park vehicles in the street during inclement weather, especially along the emergency routes which are: Neosho Street to North 4th Street (ALL of 4th Street is an emergency route), Cherokee Street to Main Street and ALL of Main Street, including Arrowhead Drive. Vehicles parked in the street make it difficult to effectively treat the streets for icy conditions as well

as impede snow removal.

Snow removal will be limited if accumulation is less than two (2) inches, designated emergency routes and school bus routes will be addressed with either snow removal or salt and/or sand treatment, possibly both. Other residential streets will be addressed after the emergency routes and school bus routes are finished.

## Easter Egg Hunt

The New Strawn Community Improvement Organization (NSCIO) will be hosting the annual Easter Egg Hunt Saturday, April 20 at the New Strawn Community Building. The time for the event is tentatively set for 10 a.m. This event is for children up to age 11. The Easter Bunny may 'hop in' for photo ops! Filling hundreds of eggs with candy and prizes is time-consuming and NSCIO always welcomes more volunteers!

**WATER RATE INCREASE:** At its Dec. 13, 2018 meeting, the Council approved Ordinance No. 2018-07 increasing water rates as follows: Within City Limits \$36.50 Water System Maintenance Fee, \$9.75 per thousand gallons of water, Minimum monthly water charge \$46.25. Outside City Limits \$36.50 Water System Maintenance Fee, \$14.27 per thousand gallons of water, Minimum monthly water charge \$50.77. Sewer and trash rates did not increase.

**CITY HALL HOURS:** City Hall regular hours are: Monday-Friday, 8 a.m. to noon and 12:30 to 2:30 p.m.

**NEWSTRAWN.ORG** is the City Hall website where you can go online to pay your bill, read minutes, read city ordinances or check out upcoming community events. You can also find forms such as new account applications, community building reservation and other licensing forms.

If paying your bill online, there is a 2.5 percent fee for credit cards and \$1.50 if paying with your checking account. To avoid these fees charges by KanPay (not the City of New Strawn), you can pay in person or use the night drop box.
