The City of New Strawn is investigating the possibility of applying for a Walter S. and Evan C. Jones Testamentary Trust Grant to make improvements/upgrades to our current Jones Park, which is located on Getz Street across from the community building. We have received confirmation from the grant management organization that they will consider any reasonable request, but they will not be the sole funder of any project. They want to see significant city/resident support of any project for consideration. The city will be forming a committee to compile information for the grant writing process and to formulate specific details of what

type of improvements need to be made, cost and what and who will be involved in carrying them out. We would like the committee to consist of residents and business owners interested and dedicated to the project. **SNOW AND ICE REMOVAL:** Old Man Winter is on his way, so just a few reminders about the city's inclement weather policy...

Please, DO NOT park vehicles in the street during inclement weather, especially along the emergency routes which are: Neosho Street to North Fourth Street (ALL of Fourth Street is an emergency route), Cherokee Street to Main Street and ALL of Main Street, including Arrowhead Drive. Vehicles parked in the street make it difficult to effectively treat the streets for icy conditions as well as impede snow removal.

The city will observe a snow removal policy implemented several years ago. Snow removal will be limited when accumulation is less than 3 inches, designated emergency routes and school bus routes will be addressed with either snow removal or salt and/or sand treatment, possibly both. Other residential streets will be addressed after the emergency routes and school bus routes are finished.

FUR BABIES NEED TO BE REGISTERED: The New Year is just around the corner which means it's almost time to register your dog or cat with the city. Animal licenses for 2018 need to be purchased at New Strawn City Hall by Jan. 31. You will need to bring your proof of rabies vaccination with you; you do NOT need to wait until it is time to have your pet vaccinated to register them. Simply bring in proof of the most recent rabies vaccination showing they are up-to-date. Some folks were under the impression they had to wait until after the vaccination date to come in and that just results in an increased fee for the registration. You can drop off an updated vaccine record at City Hall later in the year. Cost of registering your pet is: \$2 for animals that are spayed or neutered; \$5 for unaltered animals. Licenses are valid for the 2018 calendar year. If you forget to do it in January, don't panic. You can still get Fido or Fluffy registered in February or March, but the cost of the license doubles for each month you are late ... \$4 & \$10 in February, \$8 & \$20 in March.

Just a reminder, any owner or harborer of an animal that is found to be without a current license may be fined up to \$500, plus any cost incurred by the city related to enforcing the animal code. Tagging your pet is really more for your "peace of mind" than anything. Even dogs and cats that live almost entirely in the house occasionally "escape" to the great outdoors and a tag makes it so much easier to reunite an owner with an animal!

Please, do NOT attempt to venture out onto the icy lake to fish. Shoreline fishing is permissible ... ice fishing is not.

The city is VERY grateful to Casey's, Circle B Lumber & Farm Supply and Coffey County Honda in assisting us with the sale of city fishing permits. City Hall isn't open on the weekends and closes at 2:30 p.m., so these businesses offer would-be anglers a place to purchase a permit when City Hall is closed.

NEW STRAWN PLANNING COMMIS-SION NEWS: The New Strawn Planning Commission continues to work on the city's comprehensive plan and proposed new zoning and sub-division regulations. Work sessions were held on Aug. 24 and Oct. 17 and the hope is that both the plan and regulations will be ready to present at a public hearing on the matter before the end of the year.

This has been a long and arduous process and the city would like to thank all previous, and current, planning commission members, council members, zoning administrators and city clerks who had a hand in making this a reality. The New Strawn Planning Commission and Board of Zoning Appeals, although considered a government entity because the members are appointed by the mayor and approved by council, are NOT "paid employees" of the city, but rather volunteers who give of their time and knowledge to help with the betterment of our community.

<u>LET'S ADDRESS THE ISSUE</u>: For those who may still be unaware, New Strawn's post office closed on July 1, 2017. Consequently, City Hall had an address change from our former P.O. Box to:

The post office closure and address change was conveyed to customers on our website, in the last newsletter, at the bottom of every water bill, in the newspaper and at meetings, but City Hall is still experiencing an issue with folks using our old address. This is resulting in water payments not arriving by the due date of the 10th. We have waived late fees if a mailed payment was received within 1-2 days of the date due and had been addressed erroneously. However, as of Oct. 1, we no longer waive late fees for folks who are continuing to use our old PO Box address.

**NEW STRAWN BUSINESS RECEIVES** GRANT: Kansas State University has partnered with the Kansas Department of Commerce and Kansas State Bank to offer entrepreneurs across the state of Kansas the ability to access funding to help develop new ideas or grow Kansas-based goods-producing businesses. This grant program seeks to support the development of new business opportunities across the state that have the potential to generate revenue through product sales and create jobs in the near future. Grant awards from \$5,000 up to \$15,000 will be made on a case by case basis and will be judged on the strength of the application by a K-State advisory panel and approved by the Kansas Department of Commerce. New Strawn's very own Great Plains Design Center recently received a \$10,000 grant to help with marketing of their recycled glass counter tops, which are amazingly beautiful, by the way, as are all the other products that Great Plains crafts! If you've never seen their showroom, you've got to pay them a visit! Congratulations and we expect amazing things to unfold for Great Plains Design Center in the near future!

MEETING AND NEWSLETTER NOTI-FICATIONS: The public is always welcome to attend all city council and city planning meetings. City council meet-

ings are conducted in the open the second Thursday of each month. While the public generally does not participate in meeting business, a portion of each regular monthly meeting is designated for public comments. The city will notify individuals of regular and special governing body meetings or changes to regular meeting dates and times, if requested to do so. If you would like to be on our email notification list, or if you would like to receive this newsletter via email, leave your name and email address with the city clerk, or click the link on our website, newstrawn. org, to sign up that way. If you have been on a past list or are currently on our notification list, you must renew your request annually on or after Jan. 1.

\*NOTE: You MUST include your name with any requests to be added to our notification list. If City Hall receives a request via our website that seems suspicious or without all required information, you will NOT be added.

RADIANT LIFE CHURCH HELPS WITH OK KIDS AND BRINGS 'CELEBRITY' TO TOWN: Radiant Life Church helped kick off the OK Kids event this year by serving a free pancake breakfast from 7:15 to 9 a.m. at the New Strawn Community Building on Saturday, Sept. 9.

The church will also be hosting a men's event with Duck Commander's John Godwin on Saturday, Oct. 21, in New Strawn. Godwin will speak to men of all ages on the topic of "Faith, Family, Ducks – in that . Godwin is a regular cast member of the record-breaking Duck Dynasty television show and is the shipping manager at Duck Commander in West Monroe, La. A wild game lunch will be provided, at no cost prior to the event, with lunch at 11 a.m. at the New Strawn Community Building. MONSTER DASH: Coffey Health Foundation will be holding a 5K Monster Dash Oct. 28 in New Strawn. The dash, which will be an untimed Coffey County Wellness Circuit event, starts at 8:30 p.m. with p.m. on-site registration at Buddies, LLC, 255 N. Main St., New Strawn. Or, you can register by calling (620)364-2121 Ext. 4222. The course, which will start and end at Buddies, includes 2.5 miles on the Prairie Winds Golf Course cart paths (bring vour own flashlights and minors 14 and under must be accompanied by an adult). Costumes are encouraged and judging for "best ghoul" will be at 8 p.m. with the winners announced after the dash. Entry fee is \$25. There will also be a silent auction and donations are welcome as well! Proceeds from this event will benefit local scholarships and enhancements throughout Coffey Health System.

TROUT FISHING: The city has plans to stock New Strawn City Lake with trout around late January. A city fishing permit is required to fish in the city's lake and can be purchased at City Hall, Casey's, Circle B Lumber & Farm Supply and Coffey County Honda. A valid Kansas state fishing license is also required. City fishing permits are sold with a trout stamp through May 1 at the following cost: USD 244 (Burlington and New Strawn area) residents – Adult \$10, Youth \$4. Residents living outside of USD 244 will pay \$15 for an adult license and \$6 for youth. Anyone at least 16 years old must also possess a Kansas state fishing license.
