

ORDINANCE NO. 2018-05

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE CITY LIMITS OF THE CITY OF NEW STRAWN, KANSAS; INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES", EDITION 2018; PROVIDING CERTAIN PENALTIES; AMENDING CODE OF NEW STRAWN, KANSAS SECTION 14-101; AND REPEALING ORDINANCE NO. 2016-07.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEW STRAWN, COFFEY COUNTY, KANSAS:

THAT SECTION 14-101 OF THE CODE OF THE CITY OF NEW STRAWN, KANSAS IS HEREBY AMENDED.

SECTION 1. INCORPORATING "STANDARD TRAFFIC ORDINANCE". There is hereby incorporated by reference for the purpose of regulating traffic within the Corporate Limits of the City of New Strawn, Kansas, that certain code known as the "Standard Traffic Ordinance", Edition of 2018, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said "Standard Traffic Ordinance" shall be marked or stamped "Official Copy as Adopted by Ordinance No. 2018-05", and to which shall be attached a copy of this ordinance, and filed with the City clerk to be open to inspection and available to the public at all reasonable hours.

SECTION 2. REPEAL. Ordinance No. 2016-07 is hereby repealed.

SECTION 3. EFFECTIVE DATE. This Ordinance shall take effect and be in force from and after its publication in the Coffey County Republican, the official city newspaper.
