

ORDINANCE NO. 2016-01

AN ORDINANCE VACATING CERTAIN STREETS IN THE CITY OF NEW STRAWN, KANSAS AND RESERVING UTILITY RIGHTS AND EASEMENTS THEREIN.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEW STRAWN, KANSAS:

WHEREAS, the City Council of the City of New Strawn, Kansas is authorized by the provisions of K.S.A. 15-427 to vacate streets whenever necessary or expedient; and is further authorized by the provisions of K.S.A. 12-512a to reserve utility easements on vacated streets;

WHEREAS, the Governing Body deems it necessary and expedient to vacate the streets hereinafter described;

NOW, THEREFORE, be it ordained by the Governing Body of the City of New Strawn, Kansas, as follows:

Section 1. That Cherokee Circle, located in Block 10 of Re-plat of Blocks Ten (10), Eleven (11), Twelve (12), Thirteen (13), and Fourteen (14) of the Arrowhead Hills Addition to the City of New Strawn, Coffey County, Kansas is hereby vacated.

Section 2. That Pueblo Circle, located in Block 11 of Re-plat of Blocks Ten (10), Eleven (11), Twelve (12), Thirteen (13), and Fourteen (14) of the Arrowhead Hills Addition to the City of New Strawn, Coffey County, Kansas is hereby vacated.

Section 3. That Mohegan Circle, located in Block 15 of the Arrowhead Hills Addition to the City of New Strawn, Coffey County, Kansas is hereby vacated.

Section 4. That Quivira Circle, located in Block 16 of the Arrowhead Hills Addition to the City of New Strawn, Coffey County, Kansas is hereby vacated.

Section 5. Provided, however, that the City of New Strawn does hereby reserve unto the City and unto all public utilities serving the City of New Strawn a utility easement on and under all of the above described vacated streets in the City of New Strawn, entitling the City or any public utilities authorized by the City to construct, lay, install and maintain any and all utility service on and under the above described vacated streets.

Section 6. This ordinance shall take effect and be in force from and after its publication in the official newspaper for the City of New Strawn.

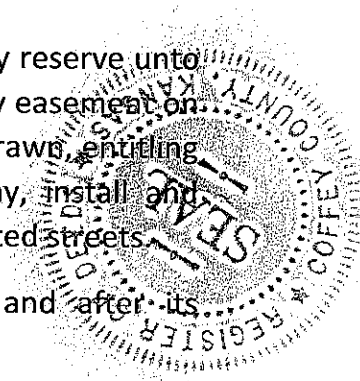

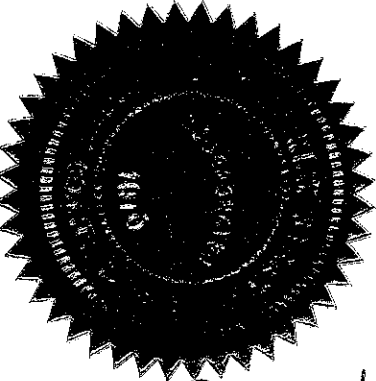
