Jane Hartley was present to ask for clarification regarding roosters in New Strawn. Mayor Mark Petterson stated that there is an ordinance. Roosters are not allowed within the corporate limits of the city of New Strawn. SEE ORDINANCE NO. 2015-10

(5) It is unlawful for any person to harbor, keep, own or possess roosters (male chickens), guinea cocks, peacocks, or other birds that by nature exhibit loud calls, within the corporate limits of the city.

Zoning Administrator's Report

- Special Use Permit for Verizon tower to be located at Northeast corner of U.S. 75 Highway and 15th Road
- Conditional use permit requests for 10 Hillside Drive and 19 Rock Ridge Drive require process of notifying residents within 1,000 feet via local newspaper and sending letters with 20-day notice that a public hearing will be held by the Planning and Zoning Board on January 16, 2019 at 6 p.m. After the Planning Commission meets and makes its recommendation, there is a 14-day protest period. A recommendation by the Planning and Zoning Board will be presented to the New Strawn City Council at its February 14, 2019 meeting.

Mayor's Report

Codification proposal received from the League of Kansas Municipalities

Mayor Petterson gave an update that the codification process from the League of Kansas Municipalities is in the editing phase. They will notify the city clerk via email when it is complete.

Finance and Economic Development Report:

Haas reported that she will meet with the city clerk to review 2018 year to date financials as they compare to the budget as we near year end totals. Haas noted that we will be in line or ahead with the General Fund, Special Park, Trash and Sewer funds. Transfers may need to be made for funds that are currently showing a loss: Special Highway Fund, Water and Infrastructure funds.

Community Building:

Fee Schedule

The Council discussed comparison of surrounding cities regarding their community building rental and deposit fee schedules provided by the city clerk. Item was tabled to the January meeting.

Community Building Door

The Council discussed the new door that was installed at the Community Center by Martin Hinman Construction. There is a concern regarding the wood frame and top possibly pooling water after a rain or snow. The city superintendent noted that it also needs a door closer. He will contact Marty Hinman to have him make necessary adjustments.

IBEW 2019 Contract

Croll moved, seconded by Weeks, to approve the 2019 contract with IBEW Local 225 in the amount of \$500.00 for its monthly meeting use of the Community Center on the third Tuesday of each month. **Motion carried 5-0.**

Council member Croll reported that a proposal was received from Alpha Roofing Company for replacement of full wall metal panel which is for the East (front) side of the Community Building in the amount of \$8,700.00. The Council will discuss at a future meeting after other bid(s) submitted.

Utility Report:

The Council discussed Water Fund and year to date reports that show loss through November. It was noted that the water tower note will be paid off in the year 2022. Different options were discussed to make up the potential 2018 loss of approximately \$5,500.00. There are currently 259 customer accounts of which 47 use less than 1,000 gallons per month and 10 who use more than 10,000 gallons per month.

Haehn moved, seconded by Weeks, to increase customers' monthly maintenance fee by \$1.00 from \$35.50 to \$36.50 and to increase customers' water usage rates by 50 cents per 1,000 gallons from \$9.25 to \$9.75 within city limits and from \$13.77 to \$14.27 outside the city limits beginning with water bills that will be due February 10, 2019. **Motion carried 3-2.** (Opposing votes – Haas and Taylor)

Lawn of the Month (October)

Council Member Haas reminded everyone that the December Lawn of the Month contest judging needs to take place from December 15th-17th. The winner to be announced on December 21st. Council members and the mayor need to submit three names each for consideration to the city clerk by Tuesday. The prize will be \$25.00 in Chamber Bucks.

• Christmas Open House

Haas stated that the Christmas Open House was not well attended; however, she and Taylor have some ideas for changes for 2019. Council members were asked to help in random selection of customers for free fishing licenses with trout stamp.

Haehn noted that he will have a more detailed report before spring. He recommended bright colored paint for the park equipment when weather allows.

Smoke-Free Policy

Council Member Weeks requested that a smoke-free policy be developed. County Commissioner Bob Saueressig stated that the county policy is for employees. It was noted that "No Smoking" signs are free through the State. The city clerk was instructed to order them for installation over doors. The city attorney will work on a policy and bring back for review.

Haehn moved, seconded by Haas, to not fund a fireworks show at Strawnfest 2019. **Motion** carried 5-0.

Strawnfest

Haas moved, seconded by Taylor, to approve contract with Trophies and Things and allow up to \$550.00 for car show trophies to be awarded at Strawnfest 2019. **Motion carried 5-0.**
